



Go to USPS website directly


- Click on https://eddm.usps.com/eddm/customer/routeSearch.action

Search for EDDM on USPS website




Select Radius Around Store




Select Neighborhoods to Drop

When you scroll over the neighborhoods you will also get the demographics for that area—age, average household income, households and businesses in that area. Once you select the neighborhood, the delivery addresses are tallied as well as the postage count. You are only able to choose up to 5000 households/businesses per order.




Additional Notes

- If you choose zip codes covered by a different post office, this information will be shown in the post office's drop-off section of the summary. This will also print out in the retail facing sheets at the end, which gives you a snapshot of the estimated cost and delivery postage and address for each post office.
- If different zip codes are selected, you must drop them off at different post office locations.




Select Drop Off Date & Payment Options
